# Change and Continuity: Amendment to the "Status of the Artist Act"

August 01, 2012

As noted in last month's *Information Bulletin*, the *Jobs, Growth and Long-Term Prosperity Act*, which received Royal Assent on June 29, 2012, amended the *Status of the Artist Act* to abolish the Canadian Artists and Producers Professional Relations Tribunal (CAPPRT) and transfer its responsibilities to the Canada Industrial Relations Board (CIRB).

It is important to note that these amendments will take effect on an unspecified future date, to be determined by the Governor in Council. Until the amendments come into force, <a href="Mailto:CAPPRT">CAPPRT</a> will continue to be fully operational and responsible for the administration of Part II of the Status of the Artist Act.

This means that all CAPPRT's regular activities, such as granting and renewing certification to artists' associations and dealing with complaints of unfair labour practices, will continue. Once the Governor in Council declares the amendments in force, any proceedings before the Tribunal will be taken up and continued by the CIRB. We encourage
