### **6. Financial Liaison's Report – Zoe Schneider**

Marcia Herback and Associates, CPA, conducted the annual financial audit for the year ending May 31, 2024. The board of directors approved the statements on August 27. The Statement of Financial Position is standard, noting unearned revenue of \$216,000. This unearned revenue is funding received from both SaskCulture and SK Arts for the 2024-25 fiscal year, received in the 2023-24 fiscal year.

Unrestricted net assets total \$38,926. This is not a huge increase from the previous year but still provides a good financial cushion for the unexpected. Operationally, SAA has good practices in place such as an external bookkeeper and segregation of duties. There are no concerns.
